## **Constitutional Provisions**

### **Election of Office Bearers**

#### **A. ELECTORAL COLLEGE**

The Electoral College for all posts of IMA T.S. and all its wings shall be the members of the State Council. (State Council members, Ex- Officio Members, Office Bearers, members of the state working committee and Central working committee), whose names have been received at the office of IMA T.S. from various branches on or before 31<sup>st</sup> March 2024.

#### **B. TERM**

For all the posts of the IMA Telangana State, the candidates cannot contest for the second term for the same post since the formation of Telangana State except for SWC and CWC.

**State Office Bearers means and denotes of an elected members only, after they are sworn at the State Council and take charge officially.**

# MODEL CODE OF CONDUCT FOR THE GUIDANCE OF CANDIDATES VOTERS AND ALL IMA MEMBERS:

These Guidelines are issued in terms of the mandate incorporated under Bye-Laws 43 (I) of Indian Medical Association Hqs. and shall be operative from the date of the Notification of IMA Elections till the completion of the process of the election.

## 1. General Guidelines Model Code of Conduct (MCC).

- a. These Guidelines shall be called as 'Model Code of Conduct (MCC).
- b. These Guidelines titled 'Model Code of Conduct (MCC) shall be applicable to all the Candidates, canvassers, Supporters, Voters and Members of IMA.
- c. No candidate shall indulge in any activity that may create mutual hatred or cause unrest among members.
- d. No personal slandering or demeaning campaign shall be permissible against any candidate or any leader of IMA.
- e. Candidates shall refrain from criticism of all aspects of private life not connected with the public activities, of the leaders, candidates, voters and members.
- f. Criticism of candidates and members on any social media print, electronic media whatsapp shall be prohibited.
- g. All candidates shall avoid scrupulously all the activities which amount to "corrupt practice" and electoral offences catalogued under the Representations of Peoples Act, such as bribing of voters, intimidation of voters, impersonation of voters or any other violations vitiating the electoral process.
- h. Organizing demonstrations by way of protesting against any candidate shall be strictly prohibited.
- i. Candidates shall ensure that they or their supporters do not create obstructions of any type in any manner in the election process.
- j. Campaigning based on Caste, Colour, Creed, Gender, Religion, Faith, Belief, Region including geographic location shall be strictly prohibited.

## 2. On the Days of Polling and Counting

- a. All candidates shall co-operate with the office bearers/scrutinisers on election duty to ensure peaceful and orderly process.
- b. All candidates and/or their authorised representatives as observers shall wear and display their identity cards provided by IMA Election Commission.
- c. All candidates shall ensure that crowding is not allowed near the IMA State building campus including road & footpath abetting the main road.

## 3. Violation of MCC

- a. Any violation of Model Code of Conduct shall be viewed scrupulously and violator shall be liable to such Disciplinary Action against him / her as warranted including Disqualification of his/her candidature and/or IMA life membership as per the laid down procedure in the governing constitution.
  - b. Decision of the Election Commission shall be final, binding and conclusive in deciding the cases of violation of Model code of conduct, The appeal can be made only complaints in writing should be made with EC/Tribunal.
  - c. Campaigning by candidates or their representative or supporters by influencing the voters by way of distribution of campaign material, providing snacks, beverages etc in the IMA Building campus is a serious violation of Model code of conduct (MCC). These violation will be leading to disqualification of the contesting candidate.
  - d. For all posts completely filled in nomination form in CAPITAL LETTERS to be sent along with Original DD., & necessary Documents of Photocopy of Life Member Certificate of IMA of the Candidate, Proposer & Secunder to be enclosed along with ID Proof (Aadhar Card /Pan Card /Driving License) of Candidate Contesting Elections duly attested and stamped by Local Branch President / local Branch secretary/State President/State secretary) to Chairman Election Commission, by Register-post or by Speed-post or Courier with acknowledgement Due.
  - e. Life Member certificate of IMA CGP / IMA AMS, and any (3) three welfare schemes membership certificate / accept of any two welfare schemes membership wherever applicable is mandatory to contest the election for any post
  - f. NO dues certificate should be submitted from state branch, and IMA welfare schemes.
  - g. D.D. for required amount should be taken on account name of "IMA Telangana State" Payable at Hyderabad. (Non Refundable Nomination fee.)
  - h. State office bearer means and denotes of an elected member only, (not nominated post) after they are sworn at the state council and take charge officially & must have completed the term of office on the date of election notification announced by election commission of IMA.
- I. Any candidate contesting for any post, should be a member of any two of three schemes of IMA FSS, FBS, PP & WS and they should not have any dues in the respective schemes.**

# GROUND FOR REJECTION OF NOMINATION

*Nomination paper of a candidate shall be rejected if*

- He/She has not attained the eligibility criteria for qualification for the post nomination filed on the date fixed for scrutiny of nominations.
- Nomination paper is not signed by candidate or subscribed by requisite number of proposers.
- Requisite Nomination fee is not paid by way of Demand draft or Banker's cheque.
- IMA life membership Certificate not submitted, and if candidate contesting election is from different state branch.
- Complete address of candidate, the proposer and the seconder has not been mentioned in nomination paper.
- Nomination paper has not been sent by registered post or by courier within the date and time prescribed for the purpose as specified in the election notification.
- Nomination paper shall be rejected on ground of false declaration relating to the information given in the nomination form. Further Failure to furnish proper no due certificates is defect of substantial character entailing rejection of nomination.
- There is No provision for retirement from contest after last date fixed for withdrawals.
- Notice of withdrawal can be submitted either email, registered post, courier or personally by the candidate himself or by his election agent, or any of his proposers but such proposer or election agent must additionally be authorized in writing by the candidate himself to present that notice on his behalf. Such notice cannot be sent to the Election commission in any other manner.
- Notice of with drawl once given by a candidate is irrevocable.
- Any other ground as decided by the election commission

4. Elections, if necessary, will be held on 27-10-2024 at IMA Telangana State office, Koti Hyderabad. Photostat copy of the nomination form will be accepted.
5. Any member or candidate misbehaving with election commission Members or doing wrong propaganda will be debarred from Contesting any post of IMA Telangana state branch for 3 years.
6. Voters list – can be obtained in the IMA state office on payment of Rs.1000/-[One thousand only].
7. Any election disputes the decision of the Chairman of the election Commission is final it can be contested only with the election tribunal of Ima Telangana state. One cannot approach any other authority other than the election tribunal.
8. Any member willing to contest can file a nomination for both years 2024-2025 & 2025-2026 or any number of posts, but the candidate can contest only for one post, after withdrawal. If the candidate does not withdraw his candidature from the contest from other posts he will be automatically disqualified., for all the posts.
9. No member shall hold the office of the President, President elect, Vice President and Hon Joint Secretaries from three zones, for more than one term of one year. No member shall hold office as Hony. State Secretary, Hon State Joint Secretary, for more than one term of two years. No member shall hold office as Hony. State Finance Secretary, for more than one term of two years.
10. No member is eligible to contest for the same office which was held by him/her earlier, from the date of IMA TS Formation except for CWC & SWC.
11. Legal jurisdiction – Hyderabad city only.
12. All the IMA members / contestant are requested to maintain decency and decorum to uphold the dignity and honour of IMA and to co-operate with the state election commission for smooth conduction of Elections.
13. The President-elect for the year 2024-2025 will be elected from Zone 2 and for the year 2025-2026 from zone- 3
14. The local branches who have not remitted the headquarters fund contribution dues in full and those branches which are defunct or suspended shall not be eligible to sponsor any candidate for state election or to franchise their votes; and this shall apply to the individual contesting member of aforementioned Local branches as well for any election in the association.
