We are regularly following all the cases at District and State Forum as of now no case at National Forum.

In the event of any legal notice and cases in the court ,member should discuss with the District Co-ordinators, Zonal vices Chairman, Zonal Joint Secretaries and council members of the scheme for any assistance if needed.

Then simultaneously their respective member should inform the State PP&WS office and keep updating the case information regularly.

We have panel of Specialists Doctors and Legal advisors who will guide the member in filing the case and reply to legal notices and if required contesting in the courts.

We request you to settle amount awarded by court immediately within 90 days otherwise interest amount has to be borne by respective members.

From March 2019 to February 2021, we have paid **Rs. 13,22,557/-** to Service Provider of his membership drive and other services.

On 03-03-2019, we had a coordination meeting with THANA Dr. M. Sampath Rao Chairman highlighted the scheme, informed about new proposal for out off the court settlements. In the meeting he also informed that now the PP&W Scheme coverage is increased from 5 lakhs to 50 lakhs in Cat-I & III, Similarly 20 to 100 lakhs in Cat-II. He also specifically emphasized that member can join in the higher risk coverage slab immediately by paying the difference in the Fee Amount.

THANA Office Bearers willingly appreciated and assured to enroll more members from their side.

PP&W Scheme council was formed with 45 Council members and two Advisors. Now we have
